- V. Dangerous & Substandard Structures

### 2017 Skylark Drive

Code Officer Kerk Gray gave a presentation regarding the disrepair of the home and its status as a dangerous structure.

Commissioner Rencurrel moved to approve the release of 2017 Skylark Drive to the City. Seconded by Commissioner Allen, the motion was approved by a vote 6-0-0.

## VI. Demolition Permit Applications

#### 1118 Gibbins Road

The applicant submitted a demolition permit application to demolish the structures at this address for a large redevelopment project. The property does not appear in the Historic Resources Survey. The adjacent property at 1116 Gibbins Road was listed as a low priority resource in the Historic Resources Survey, but has been demolished.

Commissioner Mills moved to approve the release of 1118 Gibbins Road to the City. Seconded by Commissioner Rencurrel, the motion was approved by a vote of 6-0-0.

#### 7201 Silo Road

The applicant submitted a demolition permit application to demolish the structures at this address for a large redevelopment project. The property does appear in the Historic Resources Survey as a medium priority historic resource. The adjacent property at 7301 Silo Road is also listed as a high priority resource in the Historic Resources Survey, and is also being reviewed by the LPC for historic significance at this meeting.

Commissioner Rencurrel moved to approve the release of 7201 Silo Road to the City with stipulations to grant the commission items of historical nature from the property. Seconded by Commissioner Scheid, the motion was approved by a vote of 6-0-0.

### 7301 Silo Road

The applicant submitted a demolition permit application to demolish the structures at this address for a large redevelopment project. The property does appear in the Historic Resources Survey as a high priority historic resource. The adjacent property at 7201 Silo Road is also listed as a medium priority resource in the Historic Resources Survey, and is also being reviewed by the LPC for historic significance at this meeting.

Commissioner Rencurrel moved to approve the release of 7301 Silo Road to the City with stipulations that the new development honors the Mayfield Family with a plaque so that the community knows their significance to the City of Arlington. Seconded by Commissioner Mills, the motion was approved by a vote of 6-0-0.
