

## THIRD AMENDMENT TO COWBOYS COMPLEX LEASE AGREEMENT

**THIS THIRD AMENDMENT TO COWBOYS COMPLEX LEASE AGREEMENT** (this "**Amendment**") is entered into as of November 26, 2007, between **CITY OF ARLINGTON, TEXAS**, a duly incorporated home rule city of the State of Texas ("**Landlord**"), and **COWBOYS STADIUM, L.P.**, a Texas limited partnership ("**Tenant**").

### RECITALS:

A. Landlord and Tenant entered into that certain Cowboys Complex Lease Agreement dated as of September 1, 2005 (as amended to date, the "**Lease**"; capitalized terms used but not defined herein shall have the meanings assigned to them in the Lease).

B. Landlord has acquired an interest in the tracts of real property more particularly described on **Exhibit "A-1"** and **Exhibit "A-2"** attached hereto (the "**New Land**") to be used as a part of the Cowboys Complex.

C. Landlord and Tenant desire to amend the Lease to incorporate the New Land as part of the Land under and subject to the Lease.

### AGREEMENTS:

NOW, THEREFORE, for the mutual promises herein and other good and valuable consideration, the receipt and sufficiency of which hereby acknowledged, Landlord and Tenant agree as follows:

1. **Incorporation of New Land.** The New Land is hereby incorporated into and made subject to the Lease. To give effect to the foregoing:

(a) The Lease is amended to add a new **Exhibit "A-1"** and **Exhibit "A-2"**, which are attached hereto.

(b) The definition of "**Land**" in Section 1.5 of the Lease is deleted in its entirety and replaced with the following:

**Land.** The tracts of land described on **Exhibit "A-1"** and **Exhibit "A-2"** hereto, together with such additional tracts of land as shall be hereafter acquired by Landlord for purposes of this Lease (in accordance with the Closing Conditions Agreement) and which, when combined with the tracts described in **Exhibit "A-1"** and **Exhibit "A-2"** attached hereto, shall be of a size and configuration reasonably suitable to accommodate the Cowboys Stadium and other contemplated improvements.

2. **Ratification; Binding Effect; Governing Law.** Landlord and Tenant each hereby ratifies and confirms its obligations under the Lease. Except as modified hereby, the Lease shall remain in full effect and this Amendment shall be binding upon Landlord and Tenant

and their respective successors and assigns. If any inconsistency exists or arises between the terms of the Lease and the terms of this Amendment, the terms of this Amendment shall prevail. This Amendment shall be governed by the laws of the State of Texas.


3. **Counterparts.** This Amendment may be executed in multiple counterparts, each of which shall constitute an original, but all of which shall constitute one document.




