#### **Regional Mobility Update**

This new quarterly newsletter attempts to present in one place the plans and projects underway by the City of Arlington that impact the FY2013 City Council priority of Enhancing Regional Mobility. Each issue will feature information on both longterm issues and short-term projects.



#### THE PAVEMENT CONDITION SURVEY AND ASSET MANAGEMENT

ENHANCE REGIONAL MOBILITY

In late July or early August, 2013, a pavement evaluation vehicle will once again wind its way through the streets of Arlington to capture information about street condition. The technology aboard the vehicle will record information on roughness of ride and will take high quality digital images of pavement surfaces to show pavement distress. This information is used to rate streets on an "Overall Condition Index" to assign a score that is 40% based on smoothness of ride and 60% based on the amount of damage that has affected the pavement surface.

This service is provided through a contract between the City and Applied Research Associates (ARA), a national research and engineering company, to survey one-third of the streets every three years. This year the survey will be from the north city limit to Park Row.

The City's long term goal is to have an "Overall Condition Index" rating above 70 as an average for all streets combined. Ratings are on a scale of 0-100, with a higher score meaning the street is in better condition. Right now, most Arlington streets have a rating above 70, but about 20% are rated between 50-69, and about 11% of streets have a rating below 50, which is considered "failed". The City will be concentrating on major maintenance and reconstruction of the worst streets over the next six to eight years, and then will focus on maintaining all streets in good condition, rebuilding them when they reach a rating of approximately 50.

The information provided by the survey makes this detailed analysis possible, so that staff can optimize the use of the available funding. This survey is part of the pavement management program funded by the city's street maintenance sales tax, which was first established in September, 2002. The tax is subject to re-authorization by Arlington voters every four years, with the next election coming up in 2014.

#### **Street Rating Analysis**

Information from the ARA survey is downloaded into Cartegraph, an asset and work order database and Pavement Management System, for use by City staff in determining the specific street segments that need work, and the type of work to be done, from minor maintenance to reclamation to rebuilding the entire street.

The Pavement Management System helps staff:

Maintain detailed information on city streets, in numbered segments


- Analyze and report on current street conditions
- Create models to predict possible outcomes based on funding
- Predict cost of street maintenance based upon deterioration curves

Strategically balance limited funding among priorities.
