RECOMMENDATION

Authorize the City Manager or his designee to execute an annual requirements contract for grounds maintenance of the water treatment and remote sites with Hoots Lawn Care, LLC, of Burleson, Texas, in the estimated amount of \$53,969. Hoots Lawn Care, LLC, is not an MWBE firm.

ANALYSIS

This contract is for maintaining the grounds for 25 remote water utility locations for the Arlington Water Utilities Department. A grounds maintenance cycle includes mowing, trimming, edging, and litter removal. An estimated 26 mowing cycles are included in the bid specifications over the 12-month contract period.

The Office of Business Diversity (OBD) has placed a 10% MWBE goal on this contract. Hoots Lawn Care, LLC, is currently pending certification from Women's Business Council - Southwest (WBCSW). OBD will monitor their certification status and will assist, as needed, with their efforts in meeting the MWBE contract specific goal.

FINANCIAL IMPACT

In accordance with Local Government Code 252.043, the bid was awarded based on best value criteria. Upon completion of the evaluation process by the Procurement Division and Arlington Water Utilities Department, Hoots Lawn Care, LLC, presented the best value for the City for Ground maintenance of the water treatment and remote sites in an estimated amount of \$53,969. The contract term is for one year and will be reviewed annually to determine subsequent renewal terms. The projected financial impact for this contract term is as follows:
