

SCOPE OF WORK

Request for Proposals for Arlington's Entertainment District Wayfinding Signage

1.0 INTENT

The intent of this invitation to bid is to request proposals for the City of Arlington's entertainments district's wayfinding signs. The City of Arlington is requesting competitive proposals from qualified vendors.

The City of Arlington Entertainment District Wayfinding Signage System was developed to guide visitors to major destinations within the District upon entering Arlington, such as Globe Life Field, AT&T Stadium, and Texas Live!. The current wayfinding system was designed and installed in 2009. Since then, the Entertainment District has grown with new venues and a modified parking system. The changes over the last thirteen years require the City to update the wayfinding system for the 14 million visitors each year.

The City reserves the right to make a bid award to either one vendor or to multiple vendors, whichever is in the best interest of the City. If the award is made to multiple vendors, it will be either as one vendor being the primary vendor and the other vendor the secondary vendor, or both vendors awarded jointly.

2.0 OVERVIEW

The City will be reusing the existing signage in the District; no new sign fabrication is expected. The purpose of this project is to update the existing wayfinding system by:

- 1. Refreshing the existing signs with the new powder coating and any necessary refinishing
- 2. Repairing damage to existing signs
- 3. Updating and replacing all vinyl messaging on signs
- 4. Adding new Entertainment District venues to existing signs
- 5. Reducing the total number of signs in the system to a total of 52 signs
- 6. Concentrating signs closer to the Entertainment District boundary, including Lamar Blvd, Cooper Street, Abram Street, and SH 360

3.0 VENDOR'S RESPONSIBILITIES

The chosen vendor will be expected to:

- 1. Coordinate with the City's Public Works department to collect the existing signs after the department removes them from the field. Removal and reinstallation will need to be done in stages so not all signs are down at one time.
- 2. Remove existing vinyl messaging on each sign
- 3. Repair and refinish all signs
- 4. Refurbish the sign bases according to the specifications of this Request for Proposals
- 5. Develop and install the new vinyl messaging according to the specifications of this Request for Proposals



- 6. Reinstall the Signs in the current (existing) or new locations according to the specification of this Request for Proposals
 - a. For signs that are to be reinstalled in the same location, the footings can be used for reinstallation
 - b. For signs that are to be installed in new locations, the chosen vendor will be required to build new footings according to the engineered specifications included in this Request for Proposals and dig new foundation locations for the signs.
- 7. Vendor guarantees said employees are proficiently trained and have the knowledge, skills and ability to perform in professional manner. Employ only competent, efficient employees
- 8. Provide all labor, materials, prep work, fuel, travel, power, equipment and tools, superintendence, personal protective equipment per OSHA Standards incidentals and throughout the term of the Bid Specification

4.0 CITY'S RESPONSIBILITES

- Inform the Vendor in writing when applicable or verbally when necessary that an employee whom appears to be unfit, unskilled, disobedient or is disrupting the integrity of the work site, such employee shall be removed from the worksite
- Any provision of the agreement vesting in the City or Inspector the right of supervision or inspection is understood by the parties hereto for the purpose of ensuring that the plans and specifications are complied with, and that the completed work is obtained as described herein, and no such provisions shall be interpreted as vesting in the Owner or Inspector the right to control the details of the work

5.0 FINAL INSPECTION

Contract Coordinator or designee will make final inspection of all work included, including on-site inspections while job is in progress either scheduled or randomly, and as soon as practical after the work is completed and ready for acceptance and final payment.

If the work is not acceptable to the Contract Coordinator or designee at the time of such inspection, the Contractor will be informed in writing as to the particular defects to be remedied before final acceptance will be made.

6.0 SIGN TYPES

There are three different types of signs that will be used as a part of this wayfinding system. All signs are manufactured but require refurbishment and the production of new vinyl venue panels. There are different specs for each sign type, although the three types of signs should all look cohesive as a part of one system. The C-Style Vertical TxDOT signs are approved in their style and location by TxDOT and cannot be moved or altered in any way. Blade sign types cannot be used in the TxDOT right-of-way. This system has been designed to meet these TxDOT requirements.



7.0 ENGINEERED SIGN INTALLATION DETAIL

While many of the signs are staying in their current locations, some new sign locations are being established through this Request for Proposals and will require new footings in the new location. These new footings are all in the right-of-way and must have a right-of-way permit and the new footings must be installed according to the engineered details based on the sign type, as defined in the following pages. There are thirteen new footings required in the City right-of-way, and one new footing in the TxDOT right-of-way, for a total of fourteen new footings in this wayfinding sign system. The City is intending to keep two of each sign type in inventory as replacement signs in the event that a sign is damaged. Four signs intended to be kept in reserve are damaged and need to be repaired before being placed into the Public Works inventory storage area. Photos of each sign and extent of damage with notes is included below. Repair of these damaged signs should be included in the total cost estimate for all responses to the Request for Proposals. Repaired Signs should be blank and painted black with no vinyl venue panels.
