Investment Committee Item No. 1 Minutes August 23, 2011

The meeting was called to order at 10:01 A.M.

1. Consideration of the May 18, 2011 Minutes.

A motion was made, seconded and carried by unanimous vote to approve the May 18, 2011 minutes.

2. Consideration of Investment Strategy.

David Balsamo gave an overview of the investment reports for the quarter ending June 30, 2011. The recommended investment strategy for the next three months is to maintain the weighted average maturity (WAM) range from 300 – 550 days. The operating portfolio as of June 30, 2011 had a weighted average maturity of 482 days, down from 503 days at March 31, 2011. A motion was made, seconded and carried by unanimous vote to approve the recommended investment strategy.

3. Consideration of Authorized Broker List

A motion was made, seconded and carried by unanimous vote to approve the Authorized Broker/Dealer list.

4. Other Business.

There was no other business.

5. Review of Quarterly Report for Mayor and City Council.

The Committee reviewed the quarterly report that is to be presented to the Mayor and City Council. No changes were made.

Investment Committee Item No. 2 Investment Strategy

The graphic presentations of economic indicators are presented along with the committee's investment report for 9/30/11. The Federal Open Markets Committee (the "FOMC") is not expected to increase the fed funds rate from its current range of 0 to 25 basis points until mid 2013. Unemployment dropped to 9.0% in October, the same level it was in January. Initial Jobless Claims were 390,000, about 25,000 below the average for the last year. Continuing Unemployment Claims were 3,615,000, the lowest they have been since October, 2008. The two-year Treasury note is currently yielding 0.23%, slightly up from 0.21% in August.

Housing starts for September were 658,000. This is above the average of 577,000 for the last three years. New housing permits are also historically low at 589,000. Oil is now \$98.00/barrel and has been below \$100 since it broke that level in July.

The recommended investment strategy for the next three months is to increase the portfolio WAM to a range of 300 - 580 days. The operating portfolio as of September 30 had a WAM of 631 days compared to the June 30 WAM of 482 days. Half of the portfolio is in callable securities because this is where the best values have been. Although we have exceeded the WAM limit set last time our WAC (weighted average days to call/maturity) is only 169 days.

The quarterly investment report has been prepared for the Mayor and City Council as required by Section 2256.023 Internal Management Reports of the Public Funds Investment Act.


DISCUSSION

This graph shows the book value of the main portfolio at the end of the last four quarters.


