Construction Permits

Building Permit Fees

Commercial Building permit fees charged, including Multi-Family, for: New Construction, Additions, Alterations, Remodels & Repairs of a building, shall be based on the declared valuation of the proposed work. The declared valuation shall include the fair market value of the proposed improvements, including the architectural, structural, electrical, plumbing, mechanical work, paving, parking, drive approach, and the contractor's profit with **Table 1**.

Residential permit fees charged the value of \$75.00 per square foot of area shall be used to determine the valuation for the purpose of computing permit fees in accordance with **Table 1** for the following permits: Boat Docks, Detached Garages, Permanent Storage/Accessory Buildings (over 320 sq. ft.) and Retaining Walls

For one- and two-family residential dwellings only, the square feet area shall be used for: New Construction, Additions, Alterations, Garage Conversions, Remodel & Repairs only for the purpose of computing permit fees in accordance with **Table 2**.

The Building Official may require the applicant to verify the declared value and/or square feet. The building permit fee shall be calculated based upon figures from **Table 1 and Table 2**.

Moving Permit Fees

For a permit to move a building, structure, or part of a building or structure through, upon or across any sidewalk, street, alley, highway, or other public property of the City, the fee shall be as follows:

Buildings of less than 300 square feet -when the move is completed in one day:	\$150.00
Buildings of 300 to 900 square feet	\$200.00
Buildings of more than 900 square feet	\$275.00

When a building is moved in sections, each section is considered a separate building or structure for the purpose of assessing fees.

When the move requires more than one day upon the City streets, alleys or other public property, there shall be added for each additional day an amount equal to 50 percent of the fee required for the first day.

When a building is proposed to be located within the City, an inspection fee of \$150.00 per hour plus round trip mileage is assessed to inspect the building prior to being moved.

Public Improvement Fees

Administration and Inspection Fees are payment for City services directly related to the administration, inspection, and testing of the construction or improvement of public infrastructure for a subdivision, lot, or related property development. The fees include work from the following City staff: Project Inspector, Inspection Supervisor, Utility Technicians, GIS Technicians, and Administrative staff.

The Administration and Inspection Fees are divided into two fee structures that mimic the way the fee has been historically processed, Paving and Drainage Fees and Water and Sewer Fees.

Administration and Inspection Fees will be based on the chart below. If the project has both Paving and Drainage improvements as well as Water and Sewer improvements then both columns will be necessary. If all improvements are included on one three-party contract, then the three-party contract processing fee will only be charged once.

* A project that is a residential development, less than 1 acre, and does not include water or sewer lines shall be classified as a small project and only pays a base fee of \$2,000.

** The Water Line Fee and Sewer Line Fee will be charged for all public water and sewer lines greater than 4-inches in diameter.

*** The Administration and Inspection Fee for a sewer lift station will be determined at the time of the plan submittal process. The fee will include the Base Fee of \$3,000 plus the City will obtain a quote from a 3rd party Engineering firm based on the lift station scope to perform all plan review and inspection of the lift station.

The fees above include all costs related to the City's incurred costs for administrative fees, closed circuit television video (CTTV) inspection fees, or GIS fees.

The **Paving and Drainage** fee includes inspection of SWPPP, traffic control, trench safety, ROW preparation, subgrade preparation, reinforcement placement, concrete or asphalt paving, vehicle or pedestrian signal installation, streetlight installation, driveway installation, curb ramp installation, sidewalk and sidewalk with wall installation, ADA inspection/evaluation, storm drain line installation, storm drain line taps, and any signs or pavement markings.

The **Water and Sewer** fee includes inspection of SWPPP, traffic control, trench safety, water mains, sewer mains, taps, services, manholes, fire hydrants, valves and all associated appurtenances.

Materials Testing/Pipe Testing

The fees above include all costs related to first and passing tests for all required testing. Any additional testing needed will be the contractor's responsibility.

Financial Obligation

The total Administration and Inspection Fees shall be paid prior to the City releasing the project for construction.
